Associate professor of Administrative Law at the Universitat Autónoma de Barcelona. Since 2020, she is a member of the Comissió Jurídica Assessora of the Generalitat of Catalonia and, since 2009, Director of the Enric Prat de la Riba Chair of Local Legal Studies (UAB-FAAEE), within the framework of which she directs three editorial lines on local law: ¿Soc regidor i ara què? (11 vol.), Estudis Locals (8 vol.) and Quaderns de l'Electe (5 vol.). She is also Co-Director of the Barcelona Chair of Housing Studies (2021-present), formed by the Government of Catalonia, Barcelona City Council, Universitat Autònoma de Barcelona, Universitat de Barcelona, Universitat Politècnica de Catalunya and Universitat Pompeu Fabra. She is Secretary-Treasurer of the Spanish Association of Town Planning Law.

She has been director of the Housing Agency of Catalonia (2018-2020) and president of the Commission for the Control of Non-Referendum Popular Consultations (2016-2018) —member by appointment of the Parliament of Catalonia (Presidential Decree 281/2016 of 2 August). He has directed various master's degrees, postgraduate courses and seminars on sectoral areas of action of local authorities (urban planning, leadership and local governance, administrative litigation, human resources, public sector contracting, etc.).

Researcher at the Centre for Environmental Law Studies (CEDAT) of the Rovira i Virgili University and member of the Research Group "Territory, Citizenship and Sustainability" [recognised as a Consolidated Research Group (GRC), AGAUR, Generalitat de Catalunya].

Its research activity has focused mainly on the development of various thematic lines, especially urban planning law, local law, environmental sustainability and citizen participation, which has materialised in the participation in several research projects and publications. The urban planning field has been the subject of study in many of its aspects, from the most technical (such as reparcelling) through environmental sustainability and urban regeneration processes, to the most social aspects (right to housing, tourist housing...). Specialisation at a theoretical level in this branch of administrative law has been enriched by practical knowledge of the same through participation in various regional administrative bodies (Provincial Urban Planning Commission, Expropriation Jury of Catalonia and the Sectorial Commission of Planning of the Tourism Board of Catalonia of the Department of Enterprise and Employment). This knowledge of town planning matters has been recognised by the Generalitat, with his appointment as a member of the Territorial Commission of Catalonia, a higher consultative body, due to his "recognised professional or academic prestige in town planning, housing and environmental matters" (2014-2022). In the period 2015 to 2022, he has also participated as a national speaker at the International Urban Law Congresses held in Liège (The contentious-administrative process in the field of urban planning), Barcelona (The urban protection of heritage), Trier (Urban mobility) and Bergamo-Brescia (The flexibility of urban planning) on behalf of the Spanish Association of Urban Planning Law. He was also a speaker at the 15th Congress of the Spanish Association of Administrative Law Professors (AEPDA), held in Ibiza in 2020, with the paper "Derecho a la ciudad y derechos en la ciudad", which forms the basis of a forthcoming monograph. In local law, the lines of research focus on the territorial and jurisdictional organisation of local authorities. Another line of research is the analysis of good governance, transparency and citizen participation. In 2010, he obtained, as PI, a grant from the School of Public Administration of Catalonia to delve into this issue, carrying out a 3-month stay at the University of California-Berkeley, the result of which is the work Regulation and Public Integrity.
